I am pleased to inform you that Cycling Federation of India in association with Khelo India (SAI) is organizing Khelo India Women's League Road Cycling event at Baramati Dist., Pune, Maharashtra on 23th & 24th Aug 2024 for Women Elite, Junior Girls & Sub Junior Girls including Youth Girls category. Prize money of INR 1,20,000/- (Rupees One Lakh Twenty Thousand only) will be awarded to the winners up-to 3rd places in each categories.

Other important information in respect of ROAD CYCLING is given below:-

- 1. Entry is open for all interested women cyclists for the category of Elite (19 years and above, born in the year 2005 & before), Junior (17 & 18 years, born in 2006 & 2007), Sub-Junior & Youth (born between 2008 to 2011)
- 2. No traveling allowances, boarding & lodging will be provided to the participants & Team officials. However, participants can coordinate with local organizer for other amenities.
- 3. Riders will be free to use Foreign/ Indian made bicycles during the race.
- 4. Riders are advised to carry their own bicycles & other accessories. Wearing Cycling helmets during the event is compulsory.
- 5. All Riders, participating in the event should have a valid KID number (Khelo India Id). Riders without KID, can register on NSRS Portal by clicking link given below and then they can register for the said league by using the event registration link (given below):- .  - b. Individual Road Race (Mass Start):
 - i. Elite Women 50 Km.
 - ii. Junior Girls 40 Km.
 - iii. Sub- Jr. & Youth Girls 20 Km.
