Circular: Para Cycling Selection Trials - 2024

Dear Sir/ Madam,

This is to inform you that the selection trials for the Indian Para Cycling team, for the upcoming international tournaments of road events, will be held on December 26th 2023. The trials will take place at the Service Road of ORR Medchal, Hyderabad, under the association of Cycling Federation of India.

Please note the following points for those who are interested in participating in the selection trials:

- 1) The selection will be based purely on merit, according to the predetermined timing/speed (MQS) set by CFI for each event and category. Refer to Appendix A for MQS.
- 2) Top three positions of every category, on the government cost if they make as per MQS, otherwise on their own cost. In case there are less than or equal to 3 participants, then -1 rule will be applied, i.e. Top 2 in case of 3 participants, Top 1 in case of 2 participants.
- 3) This selection is in addition to those riders who have already secured qualifying points for Paralympics 2024.
- 4) Athletes training internationally will have to submit their international event result in the last one month. The timing from the event result will be considered for qualification.
- 5) The handcycle (H1 - H5) category selection is also being considered. However, those interested in handcycling trials are required to bring their own handcycle and must comply with UCI regulations.

- 6) Athletes wishing to compete in the selection trials must be present for classification by UCI approved classifier, on December 25th 2023, at Aditya Mehta Foundation. Medical classification will be done by Ms. Asha Shaikh and Technical classification by Mr. Aditya Mehta.
- 7) Bring along the bike and required gears for bike check on December 25th 2023.
- 8) Please fill in the medical diagnostics form (MDF), related medical documents and send to secretarygeneral@cfiindia.in, dattu1012@gmail.com and ashashaikh003@gmail.com by December 20th 2023 night.
- 9) The athletes are required to arrange their own accommodation. However, the Aditya Mehta Foundation can provide accommodation upon personal request.
- 10) Transportation to and from the trials venue will be provided by Aditya Mehta Foundation.
- 11) The decision of the selection committee shall be final and binding to all.
- 12) Interested athletes must report to Aditya Mehta Foundation by 10:00 am on December 25th 2023.


