Affili This is to inform you that Cycling Federation of India is holding a selection trials on 7th & 8th Jan. 2025 for the selection of Indian Cycling team for forthcoming 44th Asian Track Cycling Championships scheduled from 21st to 27th Feb. 2025 at IG Sports Complex, New Delhi, as per the schedule attached as Annexure – I. The selection of the team will be as per the Selection policy of Cycling Federation of India (Copy of the same is enclosed herewith)

Events of Selection trials are as follows:-

Endurance events:- Individual Pursuit & Point Race Sprint events:- Sprint, 1000 Mtr. Time Trial standing start, 500 Mtr. Time Trial standing, & 250 Mtr. Standing start

Cyclists who had obtained 8<sup>th</sup> rank in their respective event at National Track Cycling Championships 2024 will be eligible for the subject trials. In case, those who are not falling under this eligibility, can also participate in the trials by depositing a fee of Rs. 1,000/-, which will be refundable, if he/she ranked within 6 in respective events at the trials.

Kindly note that no boarding/lodging will be provided during the selection trials. However, lunch will be provided at IG Sports Hostel on Selection trials day.
