Greetings from Cycling Federation of India

This is to inform you that the 2023 Masters Track World Cycling Championships is scheduled to be held at Manchester, Great Britain, from 30th Sep. to 7th Oct. 2023. For which Cycling Federation of India is organizing selection trials on 27th June 2023 at Cycling Velodrome, Shri Shiv Chhatrapati Sports Complex, Mahalunge, Balewadi, Pune, Maharashtra to select deserving cyclists from Masters category (Men & Women) Age 35 years and above, who will participate in the ibid Championship. Trials for the following events will be conducted. Entry fee of the selection trials is Rs. 3000/- per participants: -

- 1. 1000 Mtr. Time Trial
- 2. 4 Km. Ind. Pursuit

Documents for age proof must be submitted to the organizer at the time of selection trial. Rider license rule shall be applied as per the UCI rule and regulations.

No Boarding/ lodging, transportation be provided to the participants during the selection trials, however, breakfast and lunch will be provided on 27th June 2023 during the selection trials.

Kindly note that the expenses for the said championships with regard to the boarding/lodging, travelling, participation fee etc. will be borne by the participants itself.

Riders who are above 45 years of age group may attend the same at their own expenses. It will be mandatory for all participants to submit a medical fitness certificate from a registered medical practitioner to be eligible to attend the trials.
