Greetings from Cycling Federation of India!

This is to inform you that HCL in association with Cycling Federation of India is organizing HCL Cyclothon Chennai edition on 6th Oct. 2024. 55 Km. Mass Start event for Elite Men and Elite Women (age between 18-40 years) will be held on a circuit. Prize Money of Rs. 15 Lakh for Men & Women (Inclusive of necessary Income Tax deduction as applicable) will be awarded to the winners up to 10th Position in Elite Men & Women category and upto 3<sup>rd</sup> position of Team.

Kindly note that selected 50 Cyclists (30 male & 20 female) will be eligible to get lodging/ Boarding and local transportation along with to and fro sleeper train fare. Accommodation will class provided on 5th & 6th Oct. 2024 (Check out on 7th Oct 2024 morning). The selection of the 50 Cyclists (30 Male & 20 Female) will be held on the basis of their ranking in the last National Road Cycling Championships held at Vijayapur, Karnataka.

Further, other than the selected Cyclists, any other rider who wish to participate in the said Cyclothon event, can participate at their own expenses i.e. boarding, lodging & transportation. No boarding, lodging & local transport will be provided by the organizer. The entries shall be accepted from the official email of the state associations/units and only for the licensed riders only.

List of 50 Cyclists (30 Male & 20 Female) will be circulated once the Entries received from the state associations/boards.

You are requested to forward the entries of riders & officials of your State/ Board to Cycling Federation of India by 1700 Hrs. 27<sup>th</sup> Sep 2024.

Note:- It has been noticed that in previous events, entries are confirmed by State Associations but many Cyclists don't report for the event. This has become a serious issue for the organizers and in view of the above, the state/board shall be penalised Rs. 1000/- per entry for not reporting at the event and in addition the rider shall be barred for the next one event.
